On December 4, 2018, acting Chair of the Southborough Board of Selectmen switched off the audio feed of an ongoing Selectmen's meeting, so as to prevent people from observing the meeting remotely from hearing his remarks. Before doing so, Kolenda purported to recess the meeting by moving that the meeting be recessed. No other member, however, seconded his motion; and no vote was taken on the motion. As a result, the motion did not carry and the meeting continued. By shutting off the audio feed of the meeting, Kolenda concealed his remarks and the conduct of the Board. Approximately 10-15 seconds after he shut off the audio feed, Kolenda also caused the video feed of the ongoing meeting to be shut off.

The audio feed and recording was operated by Southborough Access Media, a non-profit organization that records, videos and televises live selectmen meetings so that citizens, including those with disabilities, can observe and listen to meetings remotely. Kolenda's actions interfered with Southborough Access Media's recording of the meeting and with citizens' abilities to see and observe the public meeting remotely.

Kolenda's conduct appears intentional. Once he shut off the audio feed, he angrily insulted a member of the public by calling her disgusting. He also ordered that member of the public to leave the public meeting, or he would have her escorted from the building. Both actions were improper, and it is apparent Kolenda wished to mask his wrongdoing, and prevent the creation of an audio recording of that misconduct.

On December 18, 2018, the Southborough Board of Selectmen approved inaccurate minutes of that Board's December 4, 2018 meeting. Specifically, the Board adopted minutes that reflected it had recessed its meeting after the public comment period. In truth, acting Chair Daniel Kolenda purported to recess the meeting by moving that the meeting be recessed and he simultaneously switched off the audio feed for the ongoing meeting. During the continued meeting, Kolenda angrily insulted a member of the public by calling her disgusting. He also ordered that member of the public to leave the public meeting, or he would have her escorted from the building. The Board approved minutes inaccurately reflect that the Board recessed, and they inaccurately omit Kolenda's remarks and actions.

On December 6, 2018, Louise Barron requested from Town Administrator Mark Purple a copy of the December 4, 2014 minutes, along with a copy of the contemporaneous notes taken by the Board staffer who was responsible for preparing the minutes. On December 15, 2018, Purple produced to Barron a copy of draft minutes, but not the staffer's notes. The staffer's notes are public records, and Purple failed to produce them.

The Board's and Purple's conduct appear to be an intentional effort to mask the improper actions of Daniel Kolenda at the Board's December 4, 2018 meeting.
